Eh, there – Last, but not least, our FFA requested permission (and was approved) to travel to Jutten Lake, Ontario - June 21-28 2020 for their 53rd annual fishing trip.

In 2018, the Board surveyed the community as it developed their <u>Strategic Plan</u>. Above all else, the community (500+ respondents) told the Board a very top goal should be to attract and retain high quality employees. Well, how have we been doing? That was the purpose of <u>this report</u>. Despite historic unemployment rates, the impending retirement of the



baby boom generation, and significant dips in university's teacher preparation programs, we are continuing to attract and retain highly skilled staff. To the former: this year, we hired more teachers from other school districts than in recent history. (I believe this speaks to many factors; chief among them: professionals are looking to be a part of something special.) To the latter: our non-retirement turnover rate, 3.1%, remains favorably low in comparison to the all industry standard, 18%, and Dane County industry average of 6.1%. Other growth areas remain: recruiting support staff, notably paraprofessionals, custodians, and bus drivers continues to be a challenge. In that spirit...



## In action items:

- ➤ We have some very special friends of education who wrote a check for over \$26,000 so the District could purchase 115 new Chromebooks. As part of the recently approved mathematics adoption process, our dedicated teachers have seen natural ways of connecting the <a href="Bridges">Bridges</a> program to technology. This generous gift will go a long way in achieving the teachers' vision.
- > The Board approved a three year partnership with Johnson Block, CPAs to serve as our audit firm
- Approved an extension to our contract with Bray Architects to complete work this summer that is part of our long-range facilities plan.
