Village Update RE: VOTING

Mr. Nic Owen, Village Administrator, told me, "In-person absentee voting will begin on Wednesday; to accommodate this we will be leaving the front door open and directing people to the second floor conference room. Staff will still be working in the offices, but in-person contact with be minimal and we will only allow people in by making appointments."

As it relates to COVID-19, our Board of Education has been actively engaged during these past several weeks. In fact, they held an emergency meeting on Sunday afternoon at 2:30 p.m. During last night's Board of Education meeting, members of the District's Senior Leadership Team reviewed our current status and provided an update regarding our post-April 5 contingency plans (assuming this may be necessary).

- All plans are fluid and may require a reversal of previous identified solutions.
- ➢ <u>Here</u> is the District's most recent communication related to our schools' closures. If you have not receiving these updates, please take some time to check your Infinite Campus preferences. You can access a "how to" website <u>here</u>.
- Our post-April 5 plan will likely include a hybrid "virtual" education experience. While there are many details to consider (special education services, access to computer devices and internet connections, etc.), our preparations will first focus on professional development on virtual learning skills for our instructional staff. While the idea of virtual instruction or blended learning is not new to most of our instructional team, moving instruction online for an extended time is a journey that we will all navigate together.
- ➤ Our amazing School Nutrition team made 150 meals on Monday 10 were picked up; I suspect that number will grow in the coming days. If you (or someone you know) has/have food insecurities, please share the information found on page two of this letter.
- ➤ The Department of Public Instruction shared two key pieces of information today:
  - They will waive the minimum hour requirements for instruction, provided the proper paperwork is completed and filed. Though they did not specify what that paperwork is, I have my pen ready
  - "It is increasingly clear that it will not be possible to complete testing this year due to the pandemic." Dr. Mike Thompson, Deputy Superintendent - I will keep you informed as to what that portends for our District.
- ➤ The Board of Education will continue to meet (as possible). It is important that we operate in the "sunshine." We will continue to record these meetings. In addition, we will be implementing a telephonic dial in system for those interested in listening to their important work and provide citizens' comments. More information to follow.
