The first Board of Education meeting of the 2020-21 school year took place on Tuesday night. Here are a few highlights of their important work:

<u>Summer School 2020 Report</u>: Summer School Coordinator, Mr. **Erick McCormick**, was on hand to share the results of a survey administered to families. We are pleased to report 96.1% of the 77 participants felt their student benefitted from participation. The entire report can be found <u>here</u>. While we are pleased with the results, it is important to have a growth mindset, and slide 17 helps us identify ways that we can improve. Thank you to all who participated!

<u>COVID-19 Update</u>: Since the Board last met, Public Health Madison and Dane County (PHMDC) issued a new order, <u>#9</u>. At the end of the first day of school, they provided an <u>amendment</u> to their order regarding in-person support for special education students. (The next day, Director of Student Services, Mr. **Brian Johnson**, sent a message to applicable families.) Besides the headlining news, what is also important to know:

- 1. Once we move to Step 3 in our District's <u>Gradual Reopening Plan</u>, PHMDC has changed the maximum number of people in a classroom from 25 to 15. This may cause us to revisit our plan to split students into cohorts for an AB schedule, as was previously discussed.
- 2. This graphic, from PHMDC, helps to answer the question: "When can all children in grades 3-12 return?"

Current Status

Last updated September 3, 2020; Data from August 18 to August 31

Current average number of cases per day, averaged over 14-day period: 45

Grade Levels	Target for Possibly Resuming In-Person Pupil Instruction	Status
K-2	A 14-day average of 54 or fewer cases per day, sustained for four weeks	Met on August 18, may open per Emergency Order #9
3-5	A 14-day average of 39 or fewer cases per day, sustained for four weeks	Not met
6-12	A 14-day average of 19 or fewer cases per day, sustained for four weeks	Not met

Once we achieve an average of 39 cases per day, averaged over a 14-day period, the clock will start and will be tracked on this page. Dane County will need to maintain this level for four consecutive weeks. Once that target is met, Public Health Madison & Dane County will assess reopening grades 3-5 for in-person pupil instruction. This target will be used to help inform Public Health decisions to reopen schools and will be assessed in combination with Forward Dane metrics, case trajectory (increasing, stable, or decreasing), current best practices, federal and state guidance, and unforeseen influencing factors.

As we connect with educators around the state/country this appears to be a common theme. It is leading to concerns big (no access) and small (being kicked out of meetings). While out Technology Coordinator, Mr. Josh Cataldo, assures me we have not reached the District's maximum bandwidth, we have been told simply disabling any plugins (especially third-party designed) may help to minimize problems. We remain committed to monitoring the issue and passing along any additional information/tips.
